2 home at 6318 South Fawcett, Tacoma, Washington and other discussions with him and Mr.
3 Ronnie Warren, I know that Mr. Ronnie Warren has resided at Mr. Frazier's home from 2001
4 with the exception of a time between August/September 2006 and March 2007 where I do not
5 know where Mr. Warren lived. I know Mr. Warren was residing at Mr. Frazier's home in June,
6 2007 when Mr. Warren claimed to reside in the 2300 block of South Ash Street in Tacoma.

7 Attached hereto and by this reference incorporated herein are true copies of an email
8 exchange between Mr. Warren and myself. In his email to me of August 20, 2007 he admitted
9 he did not reside at the South Ash Street address on the date he filed for the candidacy for the
10 City of Tacoma City Council District three (3). He also admitted that he ". . . stayed with
11 Tommie as you know on a day to day basis."

13 It is not right for Mr. Warren to run for office or be on the general election ballot for
14 office if he does not reside in a district that requires, as a qualification, that he live in the
15 district for a year before he files and for the entire time until his office is over (if elected).
16 These are the requirements of the Tacoma City Charter sections 2.2 and 5.4.

17 I DECLARE UNDER PENALTY OF PERJURY UNDER THE LAWS OF THE
18 STATE OF WASHINGTON THAT THE FOREGOING STATEMENT IS TRUE AND
19 CORRECT.
